FEDVIP is available to:

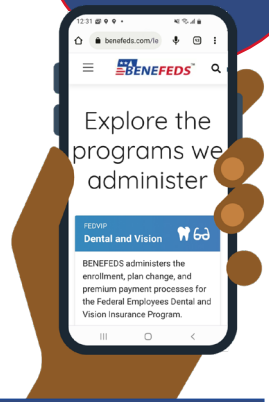
- ▶ eligible federal and U.S. Postal Service (USPS) employees, including certain temporary, intermittent, and seasonal employees
- ▶ certain emergency response and firefighter personnel
- ▶ annuitants, survivor annuitants, and compensationers
- ▶ certain uniformed service members, family, and survivors
